ii)	Indulging in rowdy or undisciplined activities by and student or students which causes or is like to cause annoyance, hardship,physical or psychological harmor to raise tear or apprehension there of in any fresher or any other student;			
iii)	Asking any student to do any act which such student will not in the ordinary coursedo and which has the effect of causing or generating a sense of shame, or tormentor embarrassment so as to adversely affect the physique or psyche of such fresheroranyotherstudent;			
iv)	Any act by a senior student that prevents, disrupts or disturbs the regular academicactivity of any other student or a fresher;			
v)	Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students:
