Item number 3: To approve academic calendar and activities for session 2023-2024.

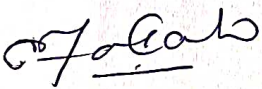

Item number 4: To discuss regarding admission of B. Sc. I students.

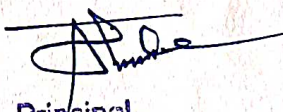

Resolution 5: No matter was raised in the meeting with the permission of the chairman and the meeting ended with a vote of thanks.




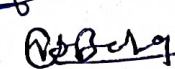
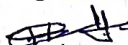

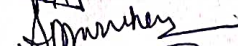

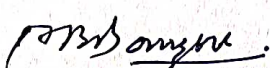
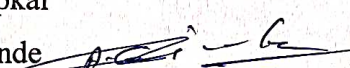
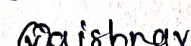
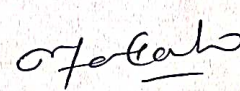

Item number 2: Updates regarding NAAC

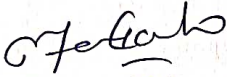

Item number 3: Review of activities as per academic calendar.

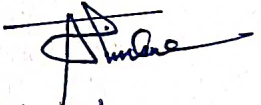

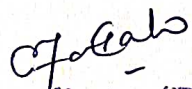
